## WCPS PREK-3

Worcester County Public Schools has developed an inclusive prekindergarten 3 classroom in each of the elementary schools. The classrooms provide children with an Individualized Education Plan (IEP) an opportunity to learn alongside typically developing peers. This program benefits students with disabilities with peer models and provides an invaluable education to all students about diversity and the importance of inclusion.

### *Inclusive, high quality early childhood programs, in the natural setting*

Once all eligibility criteria are met, entry will be on the following priority basis in conjunction with date of written referral:

- Students who are not enrolled in another preschool program
- Children of Worcester County Public Schools employees

Should additional peer models be needed once the school year has begun, students who met the criteria, will be notified of the opening.

- Be potty-trained.
- Be 3 years old by September 1<sup>st</sup>.
- Selection as an optimal peer model following Early Childhood Screening and recommendation from prekindergarten three teacher
- Must go through registration process
